

DIRECTIONS

MRS. ROWE'S BUFFET

6187 S. Valley Pike, Mt. Crawford, VA 22841

From I-81 N take exit 240 for turn onto Friedens Church Rd/VA-257W; turn onto Route -11. Continue to follow US-11. Restaurant on the right.

FRANKLIN CENTER

50 Claiborne Ave, Rocky Mount, Virginia

FROM ROANOKE, VIRGINIA

If you are traveling **from Roanoke**, VA take US 220 South to the first Rocky Mount exit. This exit puts you on North Main Street. Go 3-4 miles. You will come to a light that crosses old RR tracks and onto a bridge. Drive straight ahead (go past The Hub Restaurant), look for Claiborne Avenue on right (between Red Clay Cafe and Rocky Mount UMC). Turn right onto Claiborne Avenue, go ½ mile to The Franklin Center on left.

FROM MARTINSVILLE, VIRGINIA

If you are traveling **from Martinsville**, VA take US 220 North to the first Rocky Mount Exit (just past 619 Minute Market). This exit puts you on South Main Street. Follow South Main for 2-3 miles. Once you pass the Courthouse (on the right) you need to look for Randolph Street (on the left). Turn left onto Randolph Street, go to bottom of hill, take right into The Franklin Center parking lot. The front doors of the Center face Claiborne Avenue.

FROM LYNCHBURG AND SMITH MOUNTAIN LAKE, VA

If you are traveling **from Lynchburg/Smith Mountain Lake**, take Route 122 South to Rocky Mount. Take Right at light and go through town. (You'll pass Lowes, Walmart, on left; Sheetz on right). Continue straight. (You'll pass McDonald's on left, Franklin County High School on left). Go straight through light at high school (you'll pass Hardees on left, DMV on right). Go to top of hill, take Right onto North Main, then immediate left onto Claiborne Avenue (next to Rocky Mount UMC). Go ½ mile to The Franklin Center on left.

WYTHEVILLE MEETING CENTER

Off Interstate #77

Exit 41 - Go right on Peppers Ferry Road
Proceed approximately ¼ mile, Community Blvd will be on left (directly in front of Comfort Suites)

Off Interstate #81

North from Roanoke/Galax: - You will enter Wytheville on **I-81 South / I77**; Take **Exit 72** in Wytheville (It is best to be in the far right, outside lane and be ready to exit again)

This puts you on Interstate 77 North to Bluefield

Proceed **north on Interstate 77** (again, stay in the far right hand lane and be prepared to take the next exit)

Take exit 41, This exit dead ends into Peppers Ferry Road

Go **right** on **Peppers Ferry Road**. Proceed approximately ¼ mile, You will go under an Overpass/Bridge

The next **Left** is **Community Blvd** which runs beside Comfort Suites. Follow the meandering drive to the **2nd Canopy**, Wytheville Meeting Center, (The first Canopy is Wytheville Community Center/ Recreational Department and you will not be able to access the Meeting Center from this canopy)
